



SFI 2015-2019 — Public Summary Report ISLAND TIMBERLANDS LIMITED PARTNERSHIP

DESCRIPTION OF COMPANY

Island Timberlands LP (Island Timberlands) is a private timberlands business focused on growing, harvesting and delivering timber and other forest products from coastal British Columbia to a broad customer base. The company SFI representative is Mr. Domenico Iannidinardo, RPF, P.Eng, RPBio, VP Forest & Sustainability and Chief Forester.

AUDIT

During the period of February 11 to 13 and March 5, 2019, Island Timberlands underwent a reregistration audit to the Sustainable Forestry Initiative® (SFI®) 2015-2019 Forest Management (FM) Standard. The registration cycle is over five years with surveillance audits conducted annually. The audit assessed active and/or completed harvest operations through interviews with the company staff and contractors. The audit also assessed the SFI documentation and records at the company's office including stakeholder and First Nations communication.

The SFI program third-party audit was undertaken by SAI Global. SAI Global is an independent third party registrar that is accredited by the ANSI-ASQ National Accreditation Board (ANAB) Standard ensuring the integrity and credibility of the audit process.

THE AUDIT TEAM

The SAI Global audit team who performed the audit consisted of Mr. Jeff Koch, RPF, EMS(LA) audit team leader and Mr. Ken Hall, RFT, EMS(LA) audit team member. The auditors are forestry professionals and certified auditors.

SFI 2015-2019 Forest Management Standard

FOREST LAND AND MANGEMENT PLAN INCLUDED IN THE AUDIT SCOPE

Island Timberland's land base comprises an area of approximately 252,500 hectares (as of December 31, 2018) of Private Managed forestland on Vancouver Island, the mainland coast of British Columbia and Haida Gwaii. Forests are made up of coastal species: Douglas fir, western hemlock, balsam fir, western red cedar, cypress (yellow cedar), Sitka spruce and red alder. A range of silviculture practices are applied including regeneration harvest and partial cutting in sensitive areas.

Island Timberlands manages their forests sustainably through the balancing of timber production with the protection of key values such as water, soils, wildlife, ecological diversity, and community needs. This balance is met through their internal policies, certification standards, and legal obligations. Island Timberlands has shown that they consistently harvest at or slightly below sustainable levels.

Island Timberlands allows public access for the purpose of recreation and other approved uses when compatible with forest management policies and practices. Island Timberlands proactively reaches out to First Nations, neighbors and other stakeholders to understand their values and concerns.

SCOPE OF CERTIFICATION

The scope of registration is: Forest management activities – planning harvesting, transportation and silviculture on managed forest lands across Vancouver Island and in isolated parcels on the mainland coast, Gulf Islands and Haida Gwaii (MF74, MF19, MF21). The SFI 2015-2019 Forest Management Standard meets and exceeds the requirements of the earlier SFI 2010-2014 Standard (Section 2), therefore fiber sold under this certificate counts as 100% SFI and 100% PEFC certified forest content.

The scope has not been modified since the last public audit report.

AUDIT PROCESS

During this audit, the audit team evaluated the company against the objectives listed in Table 1. The evidence of compliance observed is listed in Table 2. Both tables are found in the section Evidence of conformity to the SFI 2015-2019 Forest management standard.

A sample of field review sites were chosen from a list of active sites and sites where forest management activities occurred since the last audit. The site choice also considered activity type, and risk factors, related to the audit objectives selected for review, as well as the opportunity to verify implementation of corrective actions for previous non-conformities.

SUBSTITUTE INDICATORS

No substitute indictors were evaluated during this audit.





COMPLAINTS

No complaints were received which could be construed as inconsistent practices contrary to the SFI 2015 – 2019 Forest Management Standard which would require reporting SAI Global for further review. Island Timberlands Limited Partnership maintains an external communication log which tracks public comments, concerns and questions and has a process in place to respond to these in a timely fashion.

Areas of non-conformance

Not applicable.

Opportunities for improvement

One opportunity for improvement was identified.

SFI Forest Management Standard Indicator 3.2.4 – Consideration could be given to instructing field operators to dispose of old Emergency Preparedness & Response Plan (EPRP) summary sheets which most carry as part of their infoFlip field SOP package. All operators sampled had the latest version of the EPRP summary sheets but some also had older copies from previous years in their possession.





Good practices

Comprehensive Island Timberlands Block Pre-Harvest Planning Checklist which includes information relating to archaeological, visual, riparian, windthrow amongst other block variables assessed during the planning phase.

Online granting of fire wood permits to the public via Island Timberlands internet site.

Comprehensive hard copy binders are maintained onsite for each block by Island Timberlands contractors containing block maps, pre works, safety and other TMS information applicable to the site.

Status of previous audit non-conformances

There were no non-conformances levied during the 2018 audit.

CERTIFICATION DECISION SFI 2015-2019 FOREST MANAGEMENT STANDARD

Re-registration Audit

Based on the results of this re-registration audit it has been determined that the management system is effectively implemented and meets the requirements relative to the scope of registration and audit criteria, therefore, a recommendation for registration is made to SAI Global.

DEFINITIONS

Major Non-Conformances

Pervasive or critical to the achievement of the SFI objectives

All major non-conformances require an action plan to be implemented by the auditee within 90 days of an initial audit or registration cannot be achieved. Subsequently for surveillance audits, an action plan shall be implemented by the auditee within 60 days for the registration to be maintained.

Minor Non-Conformances

Isolated incidents that are non-critical but must be addressed before the next surveillance audit to maintain compliance to the SFI standard. Non resolved minor non-conformance will be escalated to a major non-conformance.

Opportunity for Improvement

Are not non-conformances but are comments on specific areas where improvements can be made.

MULTI-SITE / GROUP SAMPLING APPROACH
